- The sequins represent the tears that a disabled or burned child sheds when in pain.
- The color represents the blood a disabled or burned child sheds while undergoing treatment or surgery.
- The black tassel; means we do not always save them. A few will not survive.

The Lambskin or white leather apron, is the badge of a Mason, and is the first gift of Master to the Apprentice. The apron is worn by operators to preserve their garments from spot or stain; but we as



speculative Masons use it for a more noble purpose. By the whiteness of the colour and the innocence of the animal from which it is obtained we are admonished to preserve that blameless purity of life and conduct, which will enable us to present ourselves before The Great Architect of the Universe, unstained by sin and unsullied by vice.

Silverware Fund

We have selected a simple pattern. We picked something very appealing, as our desire is to be able to rent the silverware for weddings and other events. We think that with your help we can make our goal before Christmas.

The Divan Ladies have been working hard to raise money from outside sources. We had a Craft Fair in which we rented space to crafters, served food from the kitchen and had our own booth. At that event we raised \$2,070. We also hosted the Drive Thru Dinner, serving food and raising another \$665. We have also had some larger individual donations! Thank you everyone who has donated.

As of today, the total raised is about \$5,500, but we still have a ways to go to reach our goal! Please attend any future events and donate, and bring your piggy banks to the Shrine.

James R. "Jim" Smith Elected Imperial Potentate

A BEN HUR SHRINER WILL LEAD THE FRATERNITY FOR THE 2020-2021 IMPERIAL YEAR

James R. "Jim" Smith of Georgetown, Texas, was elected Imperial Potentate, part of the 12-member body that helps govern the Shriners fraternity, in Tampa, Florida, on July 11, 2020. He is serving his 10th year as a member of the Boards of Directors for Shriners International and Shriners Hospitals for Children.

Smith became a member of the Imperial Line to make a difference. "I really thought I could help," he said. "We need to strengthen the temples and ensure they are places where people want to go, and are welcomed. We have to make it attractive to join. To put it in business terms, we need to offer a better product."

His Masonic Journey

Smith became a Mason on Feb. 13, 1999, and a Shriner in 2004. He joined the fraternity as a way to acknowledge and give back to the organizations that assisted a nephew who had orthopaedic difficulties, and received care at Shriners Hospitals for Children® — Chicago throughout his childhood.

Smith joined Zor Shriners in Madison, Wisconsin. When the family moved to Georgetown, Texas, Jim joined Ben Hur Shriners in Austin where he participated in the Provost Guard and helped transport children to and from the Texas Shriners Hospitals. He also was a member of the Board of Governors for the Houston Shriners Hospital.

In 2009, Smith served as Potentate of Ben Hur Shriners. That year, the temple had a balanced budget for the first time in many years and was awarded a Gold Membership Award for a net gain in membership. It was the first time Ben Hur Shriners had achieved gold status in 38 years.


Fun and Fellowship

Smith believes the fraternity needs to emphasize and focus on its original purpose of bringing fun and fellowship to a Masonic organization.

"When the Shriners fraternity started in 1872, its purpose was fun and fellowship," said Smith. "We did well with that – but we've lost our focus. As Imperial Potentate, I will try to put fun and fellowship back in the fraternity."

Smith has established a Fun and Fellowship Council to help find ways for "Nobles and ladies to have a good time."

Finding that "better product," and promoting it effectively, will positively impact the fraternity's membership numbers and future, which is critically important to the Shriners organization, Smith said.



Family, Faith and Education

A native of Racine, Wisconsin, Jim Smith spent his childhood summers on his father's family farm. "I really enjoyed that time. It was a great way to be raised," he said.

Growing up, the importance of family and faith were deeply instilled – to this day, he continues to uphold the conservative values and Lutheran faith of his family.

Smith received his bachelor's degree in Business Administration from the University of Wisconsin. He studied for his MBA at the Keller School of Management in Chicago.

The Smith Family

Jim Smith and Bob Jones have been friends since college; Mary Lou Jones and Alice Smith shared a classroom when both were young teachers. The two couples have many ties – including Bob's arranging a blind date to introduce the future Mr. and Mrs. Smith.

Jim and Alice were married 10 months later in Alice's hometown of Kilkenny, Minnesota, and celebrated their 48th wedding anniversary in August.

As Jim's career with a conveyor systems company progressed, the family moved quite often, mostly to various cities in Wisconsin and Minnesota, but they also spent time in Illinois and on the East Coast. Eventually, they purchased a fuel company in Phillips, Wisconsin, which was their last move before retiring to Georgetown, Texas.

The Smiths have a son, Jason, and a daughter, Abby, and five grandchildren. The fraternal tradition will continue in the Smith family for at least the next generation – both Jason and Abby's husband, Greg, are Shriners.

Joni and Sara ran the kitchen, and served cinnamon rolls and coffee in the morning, and walking tacos and chocolate chip cookies for lunch. The kitchen made a profit of \$359.11 after expenses! And we only ended up with one bag of chips left! Great job ladies!

The total profit for the event was \$2,070.97, all of which went into our Silverware Fund.



We had many compliments from the vendors on how friendly all the Divan Ladies and everyone was. All our vendors said that they would consider coming back again next year! With that in mind, it is tentatively on the calendar for September next year.

Lisa is the daughter of Marshal Brian and Barb Nelson. "More than a Game"

Fraternal Fundraising Guidelines An Excerpt from General Order No. 1: FUNDRAISING ACTIVITIES

It is natural to associate the fez with Shriners Hospitals for Children. Because of this, meticulous attention must be given to all fundraising activities, including circuses, to make certain that such activities comply with the law of the land and that a contributor is not led to believe that his money will be used for the Hospitals when all or a portion thereof will be used otherwise. The integrity of our charity and of our fraternity must remain above reproach.

Your specific attention is called to the following fraternal and charitable bylaws:

- » §335.3 Use of Name "Shriners Hospitals For Children." The use of the name "Shriners Hospitals for Children" or reference to the Hospitals in connection with any fundraising activity by a temple or Noble without the written consent of the Imperial Potentate and the chairman of the board of trustees of the Hospitals is prohibited.
- » §503.11 Commercial Use of Name. The use of the name "Shriners Hospitals for Children" or reference to the hospitals in connection with any commercial product or business enterprise is prohibited unless the written consent of the boards of directors and trustees has been first obtained.

Now, therefore, IT IS HEREBY ORDERED: 1. Fundraising for Fraternal Purposes:

- (a) No Noble (in his capacity as a Shriner), club, unit, organization of Nobles or affiliated or appendant corporations, shall engage in any fundraising activity without the express written consent of the potentate of the temple having jurisdiction thereof.
- **(b)** There can be no representation, express or implied, that the proceeds will be for the benefit of Shriners Hospitals for Children.
- (c) The temple potentate shall carefully examine all phases of the advertising, promotion and solicitation to determine that it complies with §335.3 and §503.11 of the fraternal and charitable bylaws and that there is no representation, expressed or implied, that would lead a reasonably prudent person to believe that the proceeds will be for the benefit of Shriners Hospitals for Children. If the potentate is in doubt, he must receive the opinion of the Imperial Potentate who, after consultation with the Director of Temple Accounting, shall make the final determination.
- **(d)** The temple potentate must approve the terms and provisions of any contract for a fundraising activity after receiving the advice of the temple attorney, and, additionally, as may be required by the temple bylaws.

(e) A copy of the temple potentate's written consent shall be mailed to the Executive Vice President, Shriners International. Further, such written material pertaining to the fundraising activity, as requested by the Executive Vice President, Shriners International, shall be promptly mailed to him.

2. Fundraising for Charitable Purposes:

- (a) No Noble (in his capacity as a Shriner), club, unit, organization of Nobles or affiliated or appendant corporations shall engage in any charitable fundraising activity other than for Shriners Hospitals for Children. Permission therefor must be first obtained in writing from the temple potentate. The temple potentate must then obtain written permission from the chairmen of the boards of directors and trustees. This request for written permission shall be sent to the Executive Vice President, Shriners International, P. O. Box 31356, Tampa, FL 33631-3356. No charitable fundraising activity shall be held in the jurisdiction of another temple without the written permission of the potentate of that temple.
 - (1) A joint charitable fundraising activity with another 501(c)(3) charity may be authorized, provided that a minimum of 50% of the net proceeds are for the benefit of Shriners Hospitals for Children, and the chairmen of the boards of directors and trustees determine, on a case by case basis, that it is in the best interest of Shriners Hospitals for Children and they grant their written permission for the activity.
 - (2) A charitable fundraising activity conducted by a temple located outside of the U.S.A. may be authorized for other charities, provided that the chairmen of the boards of directors and trustees determine, on a case by case basis, that it is in the best interest of Shriners Hospitals for Children and they grant their written permission for the activity.
- **(b)** All Shrine temples and their units, Shrine clubs, Shrine Associations and their units and Imperial Sessions of Shriners International are prohibited from engaging telemarketing firms and direct mail firms to assist with fundraising for Shriners Hospitals for Children. Any existing contracts may be completed, but not renewed. No new contracts are permitted without first obtaining written permission from the chairmen of the boards of directors and trustees.
- **(c)** 100% of net proceeds (as defined in the Charitable Fundraising—Approval And Reporting provisions of this General Order) from charitable fundraising must be given to Shriners Hospitals for Children except for such portion thereof as may be permitted to be retained for the temple Shrine Hospital

Patient Transportation Fund, pursuant to the Special Purpose Funds provisions of any General Order. Provided, however, if the chairmen of the boards of directors and trustees determine for good cause shown, that the law of the land requires that a portion of the net proceeds must be distributed locally, then they may, if they determine it to be in the best interest of Shriners Hospitals for Children, grant their written permission for such distribution. The remaining net proceeds from charitable fundraising must be given to Shriners Hospitals for Children and may not be designated or restricted in any way other than for research at one or all of our hospitals.

- **(d)** The temple shall report the result of each charitable fundraising activity within sixty days of the activity, pursuant to the Charitable Fundraising—Approval And Reporting provisions of any General Order.
- **(e)** This section shall not apply to activities exempt under §335.4(b) of the bylaws of Shriners International.
- (f) Each independent corporation or entity that receives the permission of the chairmen of the boards of directors and trustees to raise moneys for Shriners Hospitals for Children, and which does not have its financial statements reviewed pursuant to §§334.6 & 337.8 of the bylaws of Shriners International, shall have its financial statements audited by a certified, chartered or licensed public accountant and shall submit such audit report to Shriners International within 120 days of the activity.

3. Statement of Purpose and Disclosure:

- (a) Every fundraising activity must contain factual information on its solicitation material, tickets, programs and documents, including all electronically transmitted material, regarding the use of the proceeds. Examples: "Proceeds are for the benefit of (_______ Shriners) (______ Shrine club) activities." "Proceeds are for the benefit of Shriners Hospitals for Children."
- **(b)** Every fundraising activity which is not entirely for the benefit of Shriners Hospitals for Children shall prominently state on all solicitation material, including tickets, programs, documents and electronically transmitted material, that "payments are not deductible as charitable contributions."
- **(c)** There must be compliance with the Revenue Act of 1987 provision of any general order by U.S. temples.

4. Compliance with Applicable Laws:

It is the responsibility of the temple potentate, after receiving the advice of the temple attorney, to determine that there is compliance with all applicable laws in its jurisdiction for the temple's fundraising activities.

5. Financial Records:

(a) The temple shall maintain detailed financial records pertaining to all fundraising activities involving Nobles, clubs, units, organizations of Nobles and affiliated and appendant corporations. Details of all revenues and expenditures shall be maintained in such financial records.

- **(b)** The temple must retain such detailed financial records for a period of seven (7) years.
- **(c)** There must be compliance with Financial Reporting on Charitable Funds and Activities provision of any General Order.

6. Notification to Nobility:

A copy of the Fundraising Activities provisions of this General Order shall be printed in the temple publication at least once every calendar year. If there is no temple publication, then a copy shall be mailed to each Noble in the temple not later than the last day in March of each calendar year.

7. Prior Permission:

Every Noble (in his capacity as a Shriner), club, unit, temple, organization of Nobles or affiliated or appendant corporations is prohibited from entering into any telemarketing agreement or contract to raise money for the benefit of Shriners Hospitals for Children without first obtaining written permission from the chairmen of the boards of directors and trustees. This request for written permission shall be sent to the Executive Vice President, Shriners International, P. O. Box 31356, Tampa, Florida 33631-3356.

8. Discipline:

Any officer, Noble or temple which violates a provision of Fundraising Activities is subject to discipline pursuant to the bylaws of Shriners International.

9. Shriners International Education Foundation:

Notwithstanding the previous provisions of Fundraising Activities stated above, Nobles may contribute, encourage other Nobles to contribute and engage in charitable fundraising activities directly to Nobles and their families for the benefit of the Shriners International Education Foundation.

TREATING UNIQUE NEEDS

To help each child who comes to Shriners Hospitals for Children become as independent as possible, we often introduce and provide assistive devices, especially through our various therapy programs. We

provide our patients with physical, occupational, speech and recreational therapy.

Assistive devices can range from items to help learn or regain the ability to walk, to computer-driven augmentations for those with speech difficulties, to items that help children learn to feed or dress themselves. Assistive devices also include mobility aids, such as crutches, walkers and wheelchairs. We can also customize the devices to fit the specific needs of individual patients. The **Rising Stars** fundraising program will support these efforts.

We also use assistive technology in our therapy programs, through the availability of various systems such as body weight supported gait training and functional electrical stimulation bikes. We are also concerned with our patients' quality of life, and work to provide, or make them aware of, adaptive recreation opportunities and items to provide additional kidfriendly mobility, such as adaptive toy cars or bikes.

"We all want our children to be happy and successful," said Lady Alice. "I want to help our patients move from the Shriners Hospitals system to successful, independent adult lives."



MEMBERSHIP INCENTIVES PROGRAM REVISED Effective January 1, 2020

- 1. Each line signer, in good standing, will receive one point for a new petition, a restoration or an affiliation.
- 2. After a Noble attains five points, he will receive a membership medallion with a red, green and yellow ribbon. For each succeeding five petitions, he will receive a diamond in his membership medallion for a maximum of five diamonds. Once he has been a line signer for 35 petitions, he will receive a gold ribbon to wear with his membership medallion.
- 3. Each TOP LINE SIGNER who is a line signer for TWO Nobles in any given calendar year will be eligible to receive a "membership achiever" polo shirt.
- 4. Each TOP LINE SIGNER who is a line signer for FIVE Nobles in any given calendar year will be eligible to have his Sesostris Shrine dues paid for the next calendar year.
- 5. Line signers, if they desire, may place the Fez on their new Noble during the fezzing ceremony.
